- Distributes teaching materials to students, such as textbooks, workbooks, or paper and pencils. Maintains order within school and on school grounds.
- Operates learning aids, such as film and slide projectors and tape recorders.
- Prepares requisitions for library materials and stockroom supplies.
- Types material and operates duplicating equipment to reproduce instructional materials.
- Ability to maintain accurate Time & Effort records of program activities
- Other duties as assigned.
